Nominations are now open for the Road Safety Authority Leading Lights awards to recognise the work of committed volunteers, businesses and organisations.

NISO expresses concern at the increase in personal injuries claims in 2015

National Irish Safety Organisation (NISO) has expressed its concern over figures recently published by the injuries Board in its mid-year review. The Injuries Board reports that 17,132 new claims have been made in the first six months of 2015 representing a 7% increase on the 15,987 new claims received in the same six-month period in 2014. The mid-year review also reveals that workplace claims are up 8.5%, accidents in public places are up by almost 9% and motor claims are up 6%. The average compensation award for the first six months of 2015 is €22,375, compared to an average award of \in 22,082 in the same period last year.

Commenting on the six month figures, Mr. Maurice Priestley, Interim CEO at the Injuries Board, stated: "It is not surprising that there has been a modest increase in claims volumes year to date given the general economic upturn with more people at work and a lot more vehicles on the road. Greater economic activity would be expected to generate greater numbers of policies and premium income for insurers."

In response, NISO President, Pauric Corrigan, has stated that "While National Irish Safety Organisation welcomes the recent upturn in the economy and the volumes returning to work, it is now more important than ever for employers and employees to keep health and safety awareness at the forefront. With more and more people joining the workforce, health and safety must be the top priority to help prevent the continuation of this upward trend in accidents and claims."

Key Statistics: New claims (applications to the Board):

- New claim applications to the Injuries Board during the six months to June increased by 7% year-on-year to 17,132.
- Accidents in public places and workplace accidents are the main drivers of the 7% increase in new



claims. During the first six months of 2015, public liability claims are up by almost 9%, employer liability claims are up by 8.5% while new motor claims are up 6%.

Awards for compensation (completed claims):

- The Board made 5,741 awards for compensation to the value of €128.45 million.
- The average award of €22,375 was marginally ahead of the average award of €22,082 for the same six-month period in 2014.
- Road traffic accidents represented over three quarters (75.3%) of awards while 16.9% of awards were for accidents in public places with the remaining 7.8% relating to workplace accidents.
- Administrative costs to process awards through the Board's model have reduced to 6.6% compared to an average of 58% for cases dealt with through litigation.
- At an administrative cost of 6.6%, the cost of processing a claim through the Injuries Board is at historically low levels; €600 for those responding to a claim (typically insurers) and a refundable application fee of €45 for claimants.
- Awards were processed in an average time of 7 months in the period.
- Direct savings of €35.48 million to the end of June 2014 were achieved. Annual savings are in the region of €100 million.

SAFETY ALERT

Small Tipper Trucks



The Health and Safety Authority has issued an urgent warning to owners and operators of Tipper trucks used for transportation of construction materials, following an incident involving the failure of the pivot bar for the tipper section.

The pivot bar at the back of the truck that allows the body to lift as the hydraulic ram extends upwards to create the tipping movement, sheared at the left bracket, while the right bracket casing sheared completely allowing the body to slip off the chassis while in the raised position. The body slipped onto a worker nearby causing severe crush injuries.

It appears that the bar and brackets failed due to fatigue arising from inadequate inspection and greasing of safety critical moving parts during the lifetime of the vehicle.

Owners and operators of these vehicles are advised to include the said brackets and pivot bar in their routine servicing and inspection of these vehicles. As part of the maintenance process, the pivot bar and brackets should be inspected and greased on a regular basis and replaced where there is evidence of fatigue/failure.

Teagasc to hold Farm Safety Code of Practice Training Courses



Teagasc plan to hold a series of halfday Farm Safety Code of Practice Training Courses over the winter months.

Teagasc health and safety officer, John McNamara, said that a Teagasc study had shown the farmers who completed half-day safety training found the course highly motivating. Those who attend training identified 40% more controls for implementation. Also, the majority of farmers implement the controls they specified, and had a higher level of farms with satisfactory occupational health and safety standards.

John McNamara reminded farmers that safety training is now mandatory under the recently announced TAMS 2 schemes. To obtain payment under these schemes farmers must have completed the half-day Farm Safety course or the "Green Cert" within the previous five years.

He also called for continuing high farm safety vigilance, as the winter approaches and light fades, to cut the toll of farm deaths and serious injury.

He stated that 11 farm deaths occurred in the last four months of 2014. So far in 2015, fatal farm accident levels are 40% lower than 2014, but that one accident is one too many.

Sixty per cent of deaths in 2014 were associated with getting struck or crushed by a farm vehicle or machines, mainly in, or around the farmyard. Other major causes of accidents include livestock attacks, collapsing objects such as bales, and slurry incidents, including drowning and gassing.

This campaign emphasises that managing stress and psychosocial risks at work has significant benefits for workers, employers and the exchequer.

NISO conference told good safety is great business

The bar for safety was raised high at the NISO annual conference, the theme for which was *Good Safety is Good Business*, when delegates were told "Good safety is an expectation now days. Great safety is good business".

The words, which captured the theme of the conference, were delivered by Tony Sheridan, director of HSEQS (health, safety, environment, quality and sustainability) at Sisk. Posing the question, where should safety fit in any enterprise, Mr Sheridan said that in Sisk, 'safety is seen as being at the core of what we do".

Mentioning the business benefits of safety, he said where safety is good, quality and productivity is good. HSEQS is at the core of Sisk's construction strategies with a relentless drive towards zero accidents through behavioural change. Introducing a telling phrase into the language of health and safety, he said "each business must ask itself about the true safety costs".

Saying that good safety is not just good business, it is everyone's business, Ruairi Connor, director of group operational risk with Rexam, talked about professionals and their management teams spending too much time nose down in the tactics and not enough on developing a clear strategy to ensure all stakeholders are fully engaged. He urged delegates to lift their heads up from the tactics to ensure the strategy is in place that is going to deliver the right environment for all stakeholders.

Speaking about the importance of creating the right environment and conditions, Mr Connor said engagement, personal ownership and creativity is vital for the success of safety professionals. He said communications strategy is important. Safety must not be seen as a "show stopper", it should be seen as an "enabler". Leaders, he said, set the environment.

Mark Paradies, the president of USbased company, Systems Improvements, presented a history of the invention of process safety by Admiral Rickover of the American Navy.

With Sheridan and Connor addressing the theme of good safety is good business directly, the elements that make for good safety – a healthy workplace, managing beyond compliance, process safety, road safety and ergonomics – were addressed by a panel of expert speakers.

Healthy workplaces

Three aspects of a healthy workplace were explored.

Delivering the first presentation of the day, Joe Doddy, EAP Manager with Vhi Corporate Solutions, presented a picture of what the work environment today looks like. He spoke about 24x7 global connectivity, constant interruptions by mobile phones and workers availability outside core working hours. "The overwhelmed employee is a concern". Saying we are suffering from information overload, he said "we check out mobile devices up to 150 times a day". Employees are more fatigued, more forgetful, affected by mood contagion and are absent more.

His colleague, Lorraine Begley, an occupational health manager with Vhi

Corporate Solutions, spoke about building a more resilient workforce. There are, she said, five key steps to a healthier workplace: the physical workplace; personal health resources; involvement; the psychosocial work environment and leadership, with leadership being "the most important".

Dr Kate O'Flaherty, director of the Department of Health's health and wellbeing programme, spoke about the Government's Healthy Ireland Framework. The vision is of an Ireland "where wellbeing is valued and supported at every level of society and is everyone's responsibility". Explaining that the workplace is important, Dr O'Flaherty said World Health Organisation studies show workplaces are a "best buy" for prevention and control of chronic disease and mental health issues.

Healthy Ireland has, she said set up a cross-sectoral group to oversee the development of a healthy workplace framework. Before the end of the year, Healthy Ireland will be holding a public consultation on the concept of a healthy workplace.

Speaking about good ergonomic principles for health and safety, Katherine Metters, a chartered physiotherapist and a senior consultant with Posturite, said the hot topics of office ergonomics are agile work, hot desking and the sit-stand debate. She added "Work is changing".

When you are carrying out DSE assessments "You have to understand the full range of the person's activities". You have to watch the person work. She has, she said, noticed a shift from repetitive strain injuries to postural injuries. Stressing the importance of good seating, Ms Metters cited a study which shows good seating increases productivity by 8%.

Beyond compliance

Speaking about taking health and safety performance beyond compliance, Dr Peter J Claffey explained what compliance means to the Health and Safety Authority. It means complying

with the general duties of employers, providing information and training, having plans for emergencies, taking care for persons who are not employees, persons in control of places of work complying with their duties, identifying hazards and carrying out risk assessments and consulting with employees. For us, he said, it means complying with section 8, 10, 12, 15, 19, 20, 25 and 26 of the SHWW Act 2005. He stressed that compliance with these requirements is mandatory and is often just done to the minimum standard.

We are, he said, best known for checking compliance with the law. The results of inspections are that in only 10% of cases do we take enforcement action and serve notices. In 90% of cases we help organisations to improve and go beyond minimum standards.

Driving for work safely

Speaking about driving for work safety, Moyagh Murdock, the chief executive of the Road Safety Authority (RSA), citing provisional figures from the RSA Collision Database for 2014, said 12% of drivers who suffered injuries and 9% of those killed were driving for work. Nine percent of those injured were commuting to or from work, while 8% of those killed were commuting. Ms Murdock said a study of pre-crash behaviour over the five-year period, 2008–2012, found that one in six of drivers involved in fatal collisions were driving for work.

When questioned about employers' driving for work policies for a survey carried out for the RSA, Ms Murdock said 57% of drivers said their employer had a policy, while 37% said the employer did not have a policy. The survey found that drivers who were driving for work were more likely to admit exceeding the speed limit. She added that the survey also found those who drove for work were more likely to fall asleep at the wheel: 18% compared to 11% for all drivers.

Communications

Bringing the conference to a close, Eddie Shaw, a legendary figure in the broader safety world and now PR director at Carr Communications, highlighted some of the dangers of social media. He said:

- We no longer have time to think
- We are losing touch with people
- Our brains can no longer cope with the scale of technology
- We no longer know what are the facts
- We no longer go back to primary sources.

The Business Case for Managing Work Related Road Risk

Noel Lacey, inspector with the transport safety unit of the Health and Safety Authority, writes about the management of workrelated road risk.

Using the road for business is the leading cause of work-related deaths and injuries in Ireland. Therefore, Work-Related Road Risk Management (WRRRM) should also be a priority for businesses and organisations for legal, ethical, moral, societal, reputational and financial reasons.

Work-Related Road Safety (WRRS) is a priority program area for the Health and Safety Authority (HSA). The HSA works closely with An Garda Siochána and the Road Safety Authority to influence improvements in workrelated road safety in Ireland. The Work-Related Road Safety program aims to influence improvements in work-related road risk management, particularly in the areas of:

- driving for work,
- working on or near the road, and
- load securing for road transport.

To date, a range of resources have been jointly developed to help employers understand and manage work-related road risk including: Guidelines for Employers on Managing Driving for Work; Safe Driving for Work Driver Handbook; Driver Health Guidelines; Driving for Work Risk Assessment Checklist; Driving for Work Company Case Studies; Daily Vehicle Pre-Check instructional videos and fact sheets. These resources and many others can be downloaded for free from www.vehiclesatwork.ie.

The Authority is working closely with a range of stakeholder groups representing employers, employees, educators and business sectors such as agriculture, construction and transport to influence the uptake and integration of the Work-Related Road Risk Management message.

Does my organisation need to manage work related road risk?

Think about the following questions and if the answer is "yes" to any of them then senior management in your organisation have a responsibility to ensure that appropriate WRRRM systems and controls are in place and operating effectively:

- Do we operate vehicles for work?
- Do our employees drive for work purposes?
- Do employees or others drive on our premises?
- Do we provide employees with personal vehicles?
- Do we operate mopeds, motorcycles or bicycles?
- Do we employ/contract transport services?

The management of work-related road risk is not just for organisations with large fleets and lots of drivers, it applies to small businesses with one or two drivers. Regardless of the size of organisation or number of drivers, key risk factors to manage include speed, driving under the influence of alcohol or drugs, fatigue, stress and distraction.

Business Case for Managing Road Risk

The management of work-related road risk is centred on preventing harm to people and protecting property and the environment. It involves managing road safety in a proactive way for financial, moral and legal reasons with the aim of achieving safe drivers, journeys and vehicles. Effective management of road safety provides an opportunity to reduce costs in lots of ways. For example:

• Reduced running costs such as fuel

consumption and vehicle maintenance/repairs through better driving standards.

- Fewer working days lost to injuries.
- Less time needed for investigations and paperwork.
- Fewer missed orders and business opportunities.
- Lower insurance premiums.

Managing Young Drivers at Work

Young people continue to face a disproportionately high risk on the road, especially young males. Evidence shows that young people have the highest collision involvement of any road user group. Young drivers are not just a danger to themselves; they also pose a greater risk to their passengers and other road users.

Organisations are becoming increasingly aware of the business case for introducing road safety management programmes tailored for younger drivers. If your organisation employs younger drivers you need to consider their particular needs. The key risk factors highlighted above are even more relevant because of their age and lack of experience.

IOSH branches join forces to promote farm safety across Ireland and Northern Ireland

Agriculture continues to be one of the most hazardous industries in which to work.

In Ireland alone, 41 people have died working in the agricultural sector since the start of 2014, while a further 33 farm workers were also killed across the UK in 2014–15.

In most instances, the tragedies were as a result of incidents which involved tractors or other farm vehicles and machinery. Other cases involved handling livestock or were caused by a worker becoming trapped or crushed, drowning, suffocating or falling from height.

There have been other incidents in which people have been seriously hurt while working on farms – in many cases suffering life-altering injuries.

All of the regulators and other relevant organisations are working to promote farm safety across the UK and Ireland to make the sector safer for all.

One of the key focuses has been to encourage farm workers to try new working routines, techniques and behaviours. In many cases farm workers have been found to be employing practices which may have been used by many generations of farming families, but that are now outdated for modern-day farming.

It is against this backdrop that the Institution of Occupational Safety and Health (IOSH) prepare to host a farm and farmer safety event for workers throughout Ireland and Northern Ireland.

IOSH Ireland and Northern Ireland branches, supported by the Ireland Branch's Rural Industries Section, are to explore six scenarios which have been found to be the most common

causes of injuries or fatalities in UK and Irish agriculture – chainsaws, tractors, use of chemicals, animal management, farm building construction and electricity, and slurry management.

Each will be focussed on in-depth during a series of workshops due to take place at Teagasc's Ballyhaise Agricultural College in Co Cavan on 11 November.

Instructors from the college will join experts from Coillte and farm building management company Kilmoon Trading in leading the demonstrations, with representatives from the Health and Safety Executive Northern Ireland (HSENI) also highlighting new and emerging trends in farm safety.

Liam Howe, Chair of IOSH Ireland Branch, said: "All six are issues regularly faced by farm workers but it is not just farmers who are getting injured and killed. Their wives and children, as well as members of the general public, are also at risk. "Agriculture currently has the highest number of accident and deaths per year in Ireland. Education around improving farm and farmer safety is therefore a major priority.

"Through this event we want to support and build on the good work of the HSA, HSENI and other health services and organisations that are promoting initiatives to improve farm safety. We also recognise that IOSH, with nearly 2,000 members in Ireland, has a role to play in supporting farmers to work safely in an everchanging and demanding profession.

"We thank Ballyhaise Agricultural College for their kind permission to utilise their facilities and expertise in order to stage this important event."

IOSH Northern Ireland has been actively supporting HSENI and its Farm Safety Action Plan. The strategy, which runs until March 2017, outlines the regulator's plans to support the local farming community promote safe working and good practice.

There were 67 work-related fatalities in Northern Ireland's farming sector between 2004 and 2013. Among those killed were five children aged under 11.

Richard McIvor, Chair of IOSH Northern Ireland Branch, said members will continue to work with and support the HSENI's initiative to help reduce injuries and deaths in the farming industry.

He said: "Farm safety is an issue with relevance in both Northern Ireland and Ireland. We hope this joint event and the safety demonstrations will drive home simple and easy steps that all people involved in agriculture can take in order to make it a safer and healthier profession for all."

Áine English, Chair of IOSH Ireland Branch's Rural Industries Section, also urged farmers and anyone who promotes safety and health in the agriculture sector in Ireland or Northern Ireland, to attend.

"It is an opportunity to see highly trained specialists using safe working practices at first-hand, and to also discuss with them any challenges workers may be experiencing," she said.

The free-to-attend session will be the first that the IOSH Ireland and Northern Ireland branches have jointly held on the issue of farm safety.

Its staging also follows a number of other events that IOSH branches and districts throughout Ireland have held this year on the topic.

The IOSH Ireland Branch's Western and North Western Districts and Rural Industries Section combined to host an event in March to highlight ways of improving safety on and around farms in the west of Ireland.

Members of IOSH Ireland's North Western District also discussed the dangers of farm machinery at a meeting in July.

Help on fire safety and the duties of the fire warden



NISO team answers members' queries.

QUESTION

- (a) What are the duties of a fire warden?
- (b) How many fire wardens do I need in a building?



ANSWER

(a) What are the duties of a fire warden?

Fire wardens can have as broad or as narrow a role as you see fit, depending on various factors, such as your organisation, your fire risk, your fire prevention programme, the number of employees or even the number of floors in the building. So the role they undertake will vary from organisation to organisation. Generally they have the following role: In a nonemergency situation, they could be involved in carrying out safety checks of fire exits, fire evacuation routes, visual inspections of fire extinguishers (to ensure that they are in place and have not been tampered with etc.), water hoses, fire hydrants outside, training of other employees in fire safety awareness etc.

They will also need to be de-briefed after any emergency. In an emergency situation/fire drill they are generally assigned to a floor, department or small building and their key role is to sweep that floor/ department/building and "sweep all persons, employees and others, towards the relevant exits" so that they can declare that that floor/department/building is entirely empty. They will accompany their people to their final Assembly Point outside and check in with the evacuation co-ordinator to declare that their area is empty.

A Fire Warden should always be clearly identified and may be required to wear a hi-viz jacket with "Fire Warden" on the back, so that they are clearly seen by everyone else. When they begin their sweep they should start at the point of greatest danger and sweep away from that point. They should not enter smoky areas, as they may be overcome by smoke. They should also close all doors after them once the area is empty. They should never endanger themselves, should never open doors that are hot to the touch or spend time arguing with persons who refuse to leave - they should note who and where they are and move on.

They should then pass this information on the evacuation coordinator. One of the key issues to be taken into account during their "sweep" is that they must check all rooms in their area, toilets, showers, store rooms, stationery stores, chemical stores etc., not just open offices or factory floors. If they come across injured persons, they should make contact with the evacuation coordinator to get medical help.

Generally they do not have fire fighting roles, this is undertaken by the separate but linked emergency response team. Companies may appoint fire wardens to carry out specific duties, such as a stair fire warden.

If you are planning to appoint fire wardens, they will need specific training, which would include awareness of key fire safety duties under the law (Fire Services Act 1981 and Regulation 13 within Chapter 1 of Part 2 of the General Application Regulations 2007 – dealing with Workplace).

A training programme would typically equip them to do the following:

- Understand the emergency plan for the organisation
- Understand their own role and be competent to carry it out
- Understand and recognise habitual human behaviour in a fire situation
- Understand the basic principles of fire risk assessment
- Be aware of how to prevent fires or limit their impact
- Be aware of specific evacuation routes, exits, those with special needs who may need specific assistance in any evacuation, buddying arrangements etc. for their area
- Become familiar with areas of refuge available on their floor, if they exist
- Recognise the need for fire drills and pre-planning for fire and their role in them
- Recognise active and passive fire safety measures and facilities
- Offer assistance to anyone who may need it.

(b) How many fire wardens are required?

It all depends on your organisation, your fire risk, your fire prevention programme, the number of employees, the number of floors in the building etc. There are no hard and fast rules about the number required.

In trying to determine how many you need, your fire risk assessments will be a major determining factor and you should try to appoint and train up deputy fire wardens to cover during holiday and sickness absences.

Legislation

European Union (System for the Identification and Traceability of Explosives for Civil SES) (Amendment) Regulations [S.I. No. 201 of 2015]

This Regulation amends the European Communities (System for Identification and Traceability of Explosives for Civil Uses) Regulations 2009 (S.I. No. 133 of 2009). It clarifies the offence of persons acquiring or supplying explosives manufactured in another Member State which are not marked with a unique identification in accordance with the Commission Directive, and the enforcement measures available to an authorised officer in relation to such explosives. It also includes some minor technical amendments.

European Union (Properties of Waste which Render it Hazardous) Regulations 2015 [S.I. No. 233/2015]

These Regulations provide for measures to protect the environment and human health by preventing or reducing the adverse impacts of the generation and management of waste and by reducing overall impacts of resource use and improving the efficiency of such use and transpose Directive 2008/98/EC of the European Parliament and of the Council of 19 November 2008 on waste and repealing certain directives. In particular, these Regulations provide for the transposition of Commission Regulation (EU) No. 1357/2014 of 18 December 2014 replacing Annex III to Directive 2008/98/EC of the European Parliament and of the Council on waste and repealing certain directives.

Building Control (Amendment) Regulations 2015 [S.I. No. 243/2015]

The above Regulations provide for a revision in certain cases of the fee specified in Part A of the Fifth Schedule to the Principal Regulations in respect of an application for a Disability Access Certificate or a Revised Disability Access Certificate.

While the standard fee for an application for a Disability Access Certificate or a Revised Disability Access Certificate shall continue to be \in 800, a reduced fee of \in 500 shall apply where the application is made prior to the commencement of works and coincides with an application for a fire safety certificate, where relevant.

Clause 2(e) of Part B of the Fifth Schedule to the Principal Regulations has also been revised to clarify that where a building control authority makes a refund in respect of an application for a Disability Access Certificate or a Revised Disability Access Certificate the refund shall not reduce the balance of the fee paid in respect of such application to less than \in 500.

European Union (Railway Safety) Regulations 2013 (Amendment) Regulations 2015 [S.I. No. 280/2015]

The purpose of these Regulations is to transpose Commission Directive 2014/88/EU of 9 July 2014 which amends Directive 2004/49/EC as regards common safety indicators and common methods of calculating accident costs by replacing Annex I (Common safety indicators) in full. Directive 2004/49/EC is the principal EU Railway Safety Directive and it is transposed into Irish law by the European Union (Railway Safety) Regulations 2013 (SI No. 444 of 2013). These Regulations amend SI No. 444 of 2013 to incorporate amending Directive 2014/88/EU and new Annex I.

S.I. No. 288/2015 - European Communities (Carriage of Dangerous Goods by Road and Use of Transportable Pressure Equipment) (Amendment) (No. 2) Regulations 2015.

These Regulations transpose into Irish law Commission Directive 2014/103/EU of 21 November 2014 adapting for the third time the Annexes to Directive 2008/68/EC of the European Parliament and of the Council on the inland transport of dangerous goods to scientific and technical progress (insofar as that Directive relates to the transport of dangerous goods by road). Commission Directive 2014/103/EU gives effect to the changes to the ADR agreement that came into force on 1 January 2015. The Regulations also give further effect to Directive 2008/68/EC of the European Parliament and of the Council of 24 September 2008.

These Regulations amend for the third time the European Communities (Carriage of Dangerous Goods by Road and Use of Transportable Pressure Equipment) Regulations 2011 (S.I. No. 349 of 2011). These Regulations may be cited as the European Communities (Carriage of Dangerous Goods by Road and Use of Transportable Pressure Equipment) (Amendment) (No. 2) Regulations 2015.

European Communities (Environmental Liability) (Amendment) Regulations 2015 [S.I. No. 293/2015]

These Regulations transpose Article 38 of Directive 2013/30/EU of the European Parliament and of the Council of 12 June 2013 on safety of offshore oil and gas operations and amending Directive 2004/35/EC (Text with EEA relevance). Article 38 of Directive 2013/30/EU requires that the definition of water damage in Directive 2004/35/EC be replaced so that the definition is extended to include damage that significantly adversely affects the environmental status of marine waters as defined in Directive 2008/56/EC establishing a framework for community action in the field of marine environmental policy (the Marine Strategy Framework Directive).
