HSA publishes its Annual Report for 2023

The Health and Safety Authority (HSA) has published its 2023 Annual Report. This is the HSA's second Annual Report under its Strategy Statement 2022–2024.

Key highlights from the 2023 Annual Report include:

- Inspections completed across all economic sectors totalled 9,995 proactive inspections, 463 reactive inspections and 225 investigations completed following incident reports received.
- Eighty-three investigations undertaken into fatal accidents, of which 43 were deemed work-related.
- Nineteen prosecutions concluded, with 15 prosecuted on indictment and four prosecuted summarily, resulting in fines totalling €1,377,500.
- Forty-three work-related fatalities reported, the majority of which (72%) occurred in agriculture, fishing and forestry (20 deaths) and construction (11 deaths).
- New regulations introduced, the first of their kind in the EU, making helmet wearing and training for all quad bike operators a legal requirement.
- New Health and Social Care Advisory Committee established.

Offering her condolences to the families and friends of the 43 people who lost their lives in workplace accidents in 2023, **Minister of State for Business, Employment and Retail, Emer Higgins TD** said:

Each life lost is one too many and I urge all employers and employees to prioritise health and safety and make full use of the HSA's resources and tools. Employment in Ireland reached a record high of 74.2% in 2023. There has never been more people at work in Ireland but with more people working, we cannot become complacent. Together we can help ensure that every worker in Ireland can return home safely at the end of the day.

HSA records show an overall decrease in the rate of work-related fatalities per 100,000 workers in Ireland over the past ten years (2014–2023), from the rate of 2.8 in 2014 to 1.6 in 2023.

Noting the continued high number of workplace fatalities in the agriculture and construction sectors, particularly among the self-employed, **Conor O'Brien, CEO of the HSA** said:

We're urging all employers, but particularly the self-employed, to make health and safety a top priority as you go to work each day. As the Health and Safety Authority prepares its new 2025-2027 Strategy, I will be seeking input from our sectoral advisory committees as to how we can make a significant step change in these sectors to significantly reduce the fatality, illness and injury rates. We will continue to develop a wide range of user friendly tools and guidance to help achieve these aims.

Patricia Byron, Chairperson of the Health and Safety Authority, said:

As we publish the 2023 Annual Report, I am pleased to confirm the Board approved the establishment of a new Health and Safety Advisory Committee in 2023 to provide a forum for stakeholders to advise and support the Authority in promoting best practice in occupational health and safety in the sector. The Health and Safety Authority is committed to driving change through collaboration and innovation. I thank our stakeholders for their steadfast support and look forward to our continued partnership in advancing workplace safety."

Sun safety advice for outdoor workers

A reminder from the Health and Safety Authority (HSA) to outdoor workers and employers that sun protection is vital during summer months.

Even in overcast conditions, sun protection for outdoor workers is still crucial. The HSA is calling on both employers and employees nationwide to take proactive measures against the harmful effects of ultraviolet (UV) radiation. The HSA suggests the following actions to reduce the risks linked with UV exposure:

- Risk Assessment: Conduct thorough risk assessments to identify potential UV hazards and implement appropriate control measures.
- 2. **Education and Training:** Provide training programs to educate workers about the dangers of UV radiation and the importance of sun protection.
- Protective Clothing: Ensure that workers wear appropriate clothing, including wide-brimmed hats, longsleeved shirts, and sunglasses that offer UV protection.
- 4. **Sunscreen Provision:** Supply broad-spectrum sunscreen with a high SPF and encourage regular application.
- Scheduling Adjustments: Whenever possible, schedule outdoor work to avoid peak UV radiation times, typically between 11 am and 3 pm.
- 6. **Shade and Breaks:** Provide shaded areas and encourage regular breaks to reduce prolonged sun exposure.

Employees should also take personal responsibility for their sun safety by:

- Wearing Protective Gear: Always wear sun-protective clothing, hats, and sunglasses.
- Using Sunscreen: Apply a generous amount of broadspectrum sunscreen 20 minutes before going outside and reapply every two hours, or more frequently if sweating
- Seeking Shade: Take advantage of shaded areas during breaks and lunchtime.
- Hydration: Stay hydrated to help the body cope with heat and sun exposure.

Surge in Workplace Aggression and Harassment Reported by Employers

- Retail, Public Services, and Hospitality Among the Highest Reported Cases
- Ibec Introduces Toolkit to Tackle Workplace Aggression and Harassment

Ibec, the representative body for Irish businesses, has unveiled a new toolkit aimed at assisting companies in addressing workplace aggression and harassment. Ibec reports an increase in incidents of aggression and harassment within the workplace particularly in customerfacing sectors like retail, libraries and hospitality. These incidents often stem from factors such as gender, relationship status, sexual orientation, religion, age, disability, race or membership in the Traveller community.

A study by Circle K forecourt and convenience stores found that 75% of their retail staff have faced verbal, racial, gender-based or physical abuse from customers.

The toolkit provided by Ibec offers practical resources and guidance to help employers identify and implement effective risk controls. It covers employer responsibilities under equality and health and safety laws, and includes sample documents and checklists to aid in preventing and addressing incidents of workplace aggression and harassment. This enables employers to support employees who experience such issues. Nichola Harkin, Head of Employment Law Services at Ibec, said:

Ireland has made notable progress in combating discrimination and promoting equality. However, there is a worrying increase in harassment, abuse, and violence, often targeted at individuals based on nationality, sexual orientation, or workplace. This alarming trend appears in various settings, including workplaces. It is crucial for employers to be empowered to mitigate risks and support employees in promptly responding to and reporting incidents.

Kara McGann, Head of Skills and Social Policy at Ibec, noted:

Recent trends have heightened employers' concerns about staff safety. Libraries, pharmacies, and bookshops are increasingly targeted by 'protestors' who verbally attack and intimidate staff. These protests, reflecting global movements, present new challenges in Ireland. The rise in such behaviour is partly due to the pandemic, the Ukraine conflict, rising energy costs, inflation, and supply chain disruptions. These crises have contributed to feelings of disenfranchisement and marginalisation, leading to increased resentment and polarisation. Misinformation often fuels these sentiments, undermining social cohesion and economic collaboration.

Public Consultation on Proposed Changes to Dangerous Goods Transport Regulations

The Health and Safety Authority (HSA) invites submissions from interested parties to a public consultation on proposed draft amends to the European Communities (Carriage of Dangerous Goods by Road and Use of Transportable Pressure Equipment Regulations), 2011, (S.I. No. 349 of 2011) as amended.

The proposed draft amends aim to update the existing regulations for the inspection of national tanks for the transport of dangerous goods.

Key Proposed Changes:

- The removal of the current exemption for national fuel tanks to undergo hydraulic testing.
- The removal of tanks deemed unfit for use from service.
- The introduction of new requirements for competent persons and national tanks regarding the documentation of test procedures, retention of tank records, the issuing

of certification forms and the marking of tanks.

- The requirement for LPG Annex C tanks to be inspected by accredited inspection bodies.
- The prevention of pre-2003 tanks or tank-vehicles from being imported into the State.

SAFETY ALERT

Critical Faults in Mast Climbing Work Platforms (MCWPs)

Target Audience:

- Construction and other industries using MCWPs
- Employers, dutyholders, and anyone responsible for MCWP supply, installation, use, inspection, servicing, maintenance and thorough examination

Issue:

The Health and Safety Executive (HSE - UK) has identified a serious technical fault in MCWPs widely used across construction projects. This fault, if undetected and unrectified, could result in platforms falling from height, posing risks of serious injury or even death.

Problem Outline:

MCWPs, often referred to as "mast climbers," are used for highlevel access and maintenance, and as an alternative to traditional scaffolding. These platforms are powered and attached to vertical masts. They are crucial in construction for providing access and a working platform on tall buildings and are also used for cladding operations.

The HSE has found that some MCWPs, which rely on two independent motor drive units per mast to prevent falling at overspeed, lack adequate controls to manage this risk. Failures in these drive units can render both the centrifugal brakes (which limit descent speed) and the automatic brakes (which engage when powered travel stops) ineffective. This fault increases the risk of platforms falling with overspeed.

Immediate Actions Required:

You are advised immediately to check that the necessary control measures are in place for all MCWP in use or available for use at a work.

If the control measures are not in place, you need to withdraw the MCWPs from use until those responsible for supply, installation, use, inspection, servicing, maintenance and for thorough examination of MCWPs ensure that:

- there is the means to identify a loss of mechanical integrity in each drive unit where this is the system to prevent falling with overspeed
- each individual drive unit is fitted with a mechanical device, e.g. centrifugal brake, that automatically prevents the work platform descending at excessive speed
- damage to drive units due to platforms being powered onto buffers/base frames is prevented
- platforms and associated equipment are not damaged by physical overloading
- thorough examinations, inspections and tests, and visual and functional checks are appropriately planned and carried out

The Health and Safety Authority (HSA) has issued a Safety Alert after being made aware of a Safety Notice issued by Portwest in respect of their FFP3 Valved Dolomite Flat Folded Respirator.

Audience: Distributors, retailers, owners and users of this particle filter mask.

The HSA advises users to stop using this product **immediately** and contact Portwest.

Name: FFP3 Valved Dolomite Flat Folded Respirator

Model: P351

Batch number: XI1122APL

Barcode: 5036108260164

Risk: This product does not comply with Personal Protective Equipment (PPE) Regulations or European standard EN 149. The total filtration capacity of the mask is insufficient. Consequently, the product does not fulfil the health and safety requirements; thus, even if combined with other recommended measures, it may not properly protect the end user.

Action: In the interest of safety, Portwest request that any customer or end user with stock of P351 from this batch (XI1122APL), remove them from sale or use.

Production v Protection

Organisational Decisions

- Systems accidents have their primary origins in fallible decisions made by designers and high-level (corporate or plant) managerial decision makers.
- This is not a question of allocating blame but simply a recognition of the fact that even in the best run organisations a significant number of influential decisions will subsequently prove to be mistaken.
- Fallible decisions are an inevitable part of the design and management process.
- The question is not so much how to prevent them from occurring as how to ensure that their adverse consequences are speedily detected and recovered.
- In considering fallible decisions, it is important to be aware of the context in which high level decisions are taken.

- All organisations have to allocate resources to two distinct goals: production and safety (protection).
- In the long term, there are likely to be many occasions in which there are short term conflicts of interest.
- Resources allocated to the pursuit of production could diminish those available for safety; the converse is also true.

The dilemmas illustrated in the graphic below are exacerbated by two factors.

Certainty of outcome

• Resources directed at improving productivity have relatively certain outcomes; those aimed at enhancing safety do not, at least in the short term. This is due in large part to the contribution to stochastic elements in accident causation.

Nature of the feedback

- The feedback generated by the pursuit of production goals is generally unambiguous, rapid, compelling and (when the news is good) highly reinforcing.
- The feedback associated with the pursuit of safety goals is largely negative, intermittent, often deceptive and perhaps only compelling after a major accident or a string of accidents.
- Production feedback will, except on these rare occasions, always speak louder than safety feedback.
- This makes the managerial control of safety extremely difficult.

In summary...

- The relationship between production and protection is not equal.
- Production produces positive results that are easily understood.
- Protection in contrast is indicated by absence of negative outcomes.

The See — Saw Effect

- Organisation begins with a safety margin.
- Safety is diminished accidents occur.
- Improvements are put in place immediately after accident.
- This gives production an advantage until catastrophe.
- For example, the Davy Lamp, which was used by miners, whereas in the past, they had used a canary. The Davy lamp was much more reliable but problems arose when miners came to rely on it too much, going deeper and deeper into mines resulting in accidents occurring in bigger explosions.

Unrocked Boat

- Lengthy period without accident can lead to erosion of protection.
- It is easy to forget to fear things that rarely happen.
- The result is an investment fall off in the care and maintenance of existing defences.
- Decision makers do not always interpret feedback on either the production or the safety channels accurately.
- Defensive "filters" may be interposed that both protect them from bad news and encourage extra punitive reactions.
- Thus poor achievement on the production front can be blamed



upon an inadequate workforce, union interference, market forces, world recession, shortages of materials and the like.

- A bad safety record can be attributed to operator carelessness or incompetence.
- This position is sometimes consolidated by cataloguing the various safeguards, engineered safety devices and safe operating practices that have already been implemented.
- Indeed, given the almost diabolical nature of some accident sequences, these are perfectly understandable reactions.
- However, this could block the discovery of effective remedies and contribute to further fallible decisions.

This trade-off between production and protection is hugely important to recognise and to stay on top of to maintain high safety standards.
